Member eligibility

To qualify for LISC AmeriCorps service, you must:

- Be 17 years or older
- Have a high school degree, a GED, or must agree to achieve their GED within the term of service
- Be a U.S. citizen or permanent resident
- Consent to complete a national sex offender registry check, a state criminal record check, and a FBI level check (paid for by LISC AmeriCorps)
- Have an interest and ability to work with diverse groups of people in neighborhoods characterized as low-wealth
- Be eligible to receive an education award (if an AmeriCorps Alum/prior service experience)


